

Better you in 2022 prize draw terms and conditions

1. The promoter is: Active Nottingham whose registered office is at Nottingham City Council, Sport and Leisure, Resident Services, Loxley House, Station Street, Nottingham, NG2 3NG
2. The competition is open to current Active Nottingham members (Fitness+ and Swim+ members) of the United Kingdom aged 18 years or over except employees of Active Nottingham.
